ORDINANCE NUMBER 08-09

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, ADOPTING RULES AND REGULATIONS FOR "MOTORIZED PLAY VEHICLES" BY REFERENCE AS ARTICLE 12-4 OF THE MARICOPA CITY CODE AND PROVIDING FOR SEVERABILITY AND THE EFFECTIVE DATE THEREOF

WHEREAS, that certain document known as Article 12-4 Motorized Play Vehicles was adopted as a public record by Resolution No. 08-55 on October 21, 2008;

WHEREAS, the Mayor and City Council of the City of Maricopa believe, after consultation with its staff and upon public hearing, that adopting rules and regulations for motorized play vehicles would be in the best interest of the City of Maricopa; and

WHEREAS, A.R.S. §9-802 allows a City to adopt a public record by Ordinance as a means to reduce publication costs while ensuring that the public gets fair notice and opportunity to review its operative provisions.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AS FOLLOWS:

SECTION 1. Pursuant to Arizona Revised Statutes Section 9-802, that certain document known as the "Article 12-4 Motorized Play Vehicles," three copies of which are on file in the office of the City Clerk of the City of Maricopa, Arizona, which document was made a public record by Resolution No.08-55 of the City of Maricopa, Arizona, is hereby referred to, adopted and made a part hereof as if fully set out in this Ordinance.

SECTION 2. Chapter 12 of the Maricopa City Code, entitled Traffic, and all amendments thereto are hereby amended by adding "Article 12-4 Motorized Play Vehicles," which was made a public record by Resolution No.08-55 of the City of Maricopa, Arizona.

SECTION 3. Violations of any provision of Article 12-4 are civil traffic violations and shall be cited and penalized in the same manner as provided by law for other civil violations.

SECTION 4. To the extent of any conflict between other City Ordinances and this Ordinance (and the Code enacted hereby), this Ordinance shall be deemed to be controlling; provided, however, that this Ordinance is not intended to amend or repeal any existing City Ordinance, Resolution or regulation except as expressly set forth herein.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions

thereof.

SECTION 6. This Ordinance shall become effective thirty (30) days after its adoption.
