

**ORDINANCE NUMBER 11-04**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, ADOPTING "AMENDMENT 2 TO CHAPTER 3 OF THE MARICOPA CITY CODE" BY REFERENCE WHICH AMENDS SECTIONS 3-11, 3-20, 3-21, 3-23 AND 3-213 OF THE MARICOPA CITY CODE AND PROVIDING FOR SEVERABILITY AND THE EFFECTIVE DATE THEREOF.**

**WHEREAS**, that certain document known as the "Amendment 2 to Chapter 3 of the Maricopa City Code" was adopted as a public record by Resolution No. 11-08 on February 15, 2011;

**WHEREAS**, on June 1, 2004, the City of Maricopa adopted Chapter 3 Administration as part of the City Code;

**WHEREAS**, on May 20, 2010, the Mayor and Council adopted Ordinance 10-06 amending Chapter 3 Administration of the Maricopa City Code; and

**WHEREAS**, the Mayor and City Council of the City of Maricopa believe, after consultation with its staff, that amending Sections 3-11, 3-20, 3-21, 3-23 and 3-213 would be in the best interest of the City of Maricopa; and

**WHEREAS**, A.R.S. §9-802 allows a City to adopt a public record by Ordinance as a means to reduce publication costs while ensuring that the public gets fair notice and opportunity to review its operative provisions;

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AS FOLLOWS:**

**SECTION 1.** Pursuant to Arizona Revised Statutes Section 9-802, that certain document known as "Amendment 2 to Chapter 3 of the Maricopa City Code," three copies of which are on file in the office of the City Clerk of the City of Maricopa, Arizona, which document was made a public record by Resolution No. 11-08 of the City of Maricopa, Arizona, is hereby referred to, adopted and made a part hereof as if fully set out in this Ordinance.

**SECTION 2.** Sections 3-11, 3-20, 3-21, 3-23 and 3-213 of the Maricopa City Code and all amendments thereto are hereby repealed in their entirety and replaced with the language set forth in "Amendment 2 to Chapter 3 of the Maricopa City Code" which was made public record by Resolution No. 11-08 of the City of Maricopa, Arizona.


**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court

of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.


**SECTION 4.** This Ordinance shall become effective thirty (30) days from the date of adoption by the City Council for the City of Maricopa.

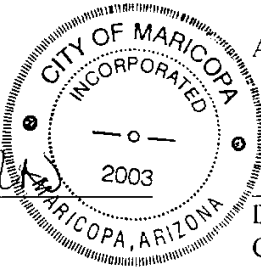


