

**ORDINANCE NUMBER 19-02**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AMENDING SECTION 2-82(1)(a)(i) OF THE CITY CODE OF MARICOPA REGARDING COUNCIL ESTABLISHED STANDING COMMITTEES TO ELIMINATE THE NON-PROFIT FUNDING EVALUATION COMMITTEE AND THE VETERAN AFFAIRS COMMITTEE AND ELIMINATING THE YOUTH INTERNSHIP PROGRAM ADVISORY COMMITTEE WHICH WAS SEPARATELY ESTABLISHED BY CITY COUNCIL.**

**WHEREAS**, Council previously adopted Section 2-82(1)(a)(i) of the City Code to establish several standing committees; and

**WHEREAS**, on October 21, 2014 Council separately established a Youth Internship Program Advisory Committee; and

**WHEREAS**, the Mayor and Council of the City of Maricopa, Arizona, have reviewed Section 2-82(1)(a)(i) of the Code of the City of Maricopa concerning the standing council subcommittees and the previous creation of the Youth Internship Program Advisory Committee; and

**WHEREAS**, after consultation with staff, the Mayor and Council of the City of Maricopa, Arizona, have determined that such section should be revised to eliminate the Non-Profit Funding Evaluation Committee and the Veteran Affairs Committee and that the separately established Youth Internship Program Advisory Committee shall also be eliminated.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AS FOLLOWS:**

**SECTION 1.** Section 2-82(1)(a)(i) of the City Code of Maricopa, entitled Council Standing Subcommittees, and all amendments thereto are hereby repealed in its entirety and replaced with the following:

- (i) Council Established Standing Committees
  - A. Parks, Recreation and Libraries Advisory Committee
  - B. Transportation Advisory Committee
  - C. Heritage District Citizen Advisory Committee
  - D. Age-Friendly Maricopa Advisory Committee
  - E. Cultural Affairs Committee
  - F. Arts Committee

**SECTION 2.** The previously established Youth Internship Program Advisory Committee is hereby eliminated.

**SECTION 3.** To the extent of any conflict between other City Ordinances and this Ordinance, this Ordinance shall be deemed to be controlling; provided, however, that this Ordinance is not intended to amend or repeal any existing City Ordinance, Resolution or regulation except as expressly set forth herein.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.


**SECTION 5.** This Ordinance shall become immediately effective thirty (30) days from the date of its passage and adoption by the City Council of the City of Maricopa.


