ORDINANCE NO. 22-16

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, APPROVING AND ADOPTING AN AMENDMENT TO THE CITY'S ZONING MAP TO REZONE APPROXIMATELY 10 ACRES OF LAND GENERALLY LOCATED AT THE SOUTHWEST CORNER OF N. PORTER ROAD AND IRON POINT ROAD, JUST SOUTH OF THE MARICOPA-CASA GRANDE HIGHWAY, WITHIN THE CITY OF MARICOPA INCORPORATED LIMITS, FROM EXISTING GENERAL BUSINESS (CB-2) TO HIGH DENSITY RESIDENTIAL (RH) AS DESCRIBED IN ZONING CASE #ZON 21-08. THE PARCEL OF LAND IS LOCATED IN A PORTION OF THE EAST HALD OF SECTION 35, TOWNSHIP 4 SOUTH, RANGE 3 EAST OF THE GILA AND SALT RIVER BASE AND MERIDIAN, PINAL COUNTY, ARIZONA.

WHEREAS, on November 4, 2014, the City adopted as a public record a new zoning code as part of the Maricopa City Code, which has been amended from time to time; and

WHEREAS, City staff initiated a Public Participation Plan to inform residents of the proposed rezoning of approximately 10 acres from General Business (CB-2) as defined in the City's old Zoning Code to High Density Residential (RH), which included a neighborhood meeting, notification letters to nearby property owners, public notice signs, and legal notices as required by law; and

WHEREAS, the City's Planning and Zoning Commission held a public hearing on May 23, 2022, in zoning case #ZON 21-08, in the manner prescribed by law for the purpose of amending the City Zoning Map to rezone the subject property.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Maricopa, Arizona as follows:

Section 1. That the Maricopa Zoning Map is hereby amended by changing the property described in Exhibit A on approximately 10 acres from General Business (CB-2) as defined in the City's old Zoning Code to High Density Residential (RH) as described in zoning case ZON 21-08. The Development Services Department shall amend the Zoning Map to reflect this amendment and a copy shall remain on file in the office of the City Clerk of the City of Maricopa for examination by the public.

<u>Section 2</u>. Further, those conditions of approval imposed by the Maricopa City Council as part of zoning case ZON 21-08 are hereby expressly incorporated into and adopted as part of this Ordinance by this reference.

<u>Section 3</u>. To the extent of any conflict between other City Ordinances and this Ordinance, this Ordinance shall be deemed to be controlling; provided, however, that this Ordinance is not intended to amend or repeal any existing City Ordinance, Resolution or regulation except as expressly set forth herein.

Section 4. This Ordinance shall become effective thirty (30) days from the date of adoption by the City Council for the City of Maricopa.
