

**RESOLUTION 04-18**

**A RESOLUTION OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING THE IMPOSITION AND COLLECTION OF FEES FOR PERMITS AND SERVICES RELATING TO THE PLACEMENT OF SIGNS WITHIN THE CITY OF MARICOPA AND ESTABLISHING THE CITY OF MARICOPA SIGN PERMIT FEE SCHEDULE**

**WHEREAS**, pursuant to Chapter 16 of the Maricopa City Code, any person or entity seeking to place or erect certain signs within the City must obtain a permit and may place such sign conditioned upon the inspection and express approval of the City; and

**WHEREAS**, the City Council has determined that the imposition and collection of fees for such services is necessary to allow the City to conduct all necessary reviews and issue all appropriate permits and approvals, and that the persons primarily benefitting from such work should bear a reasonable portion of the costs therefore;


**NOW, THEREFORE, BE IT RESOLVED** that the Maricopa City Council hereby authorizes the Development Services Department or its designees to charge, in addition to other Fees as may be specifically set forth by state law, Ordinance or Resolution, the fees as set forth in Exhibit A hereto in response to requests for permits, reviews or approvals for the placing of signs.

Three copies of the Maricopa Sign Permit Fee Schedule established in Exhibit A shall be kept on file with the City Clerk and kept available for public use and inspection.


The Maricopa City Council directs that all fees collected under this Resolution shall be deposited with the City's Director of Finance. The Director of Finance shall account for all fees deposited in accordance with accounting policies and regulations adopted by the City.



SIGN PERMIT FEE**

**Exhibit A  
City of Maricopa  
Sign Permit Fees**

<b>Comprehensive Sign Package Design Review</b> (for PADs, subdivisions, shopping centers, etc.)	\$200.00
<b>Sign Permits</b>	Fees include Plan Review, Initial Inspection and One Re-Inspection
<b>One Sign</b>	\$140.00
<b>Each Additional Sign</b>	\$60.00
<b>Grand Openings, Banners, Pennants or Displays</b>	\$25.00 each event
<b>2<sup>nd</sup> and each additional reinspection</b>	\$50.00
<b>Unauthorized installation of signs</b> (where work, for which permit is required, is started or proceeded with prior to obtaining permit)	Double the normal fees associated with the permitting, installation and inspections (provided, however, that the payment of such fee shall not relieve any person from fully complying with the requirements of the Code nor from the assessment of any other penalty or remedy provided therein)
