

**RESOLUTION NO. 04-22**

**WHEREAS**, the 387 Domestic Water Improvement District was formed pursuant to A.R.S. Section 48-905(C), by the Board of Supervisors of Pinal County, on May 21, 2003, prior to the City of Maricopa's incorporation; and

**WHEREAS**, portions of the 387 Domestic Water Improvement District are currently located both within the incorporated area of the City of Maricopa and the unincorporated area of Pinal County, Arizona; and


**WHEREAS**, the 387 Domestic Water Improvement District is a noncontiguous District within six (6) miles of the incorporated area of the City of Maricopa; and

**WHEREAS**, A.R.S. Section 48-902(G), requires that if the proposed boundaries of a noncontiguous domestic water improvement district are located within six (6) miles of an incorporated city or town, the District shall obtain the consent of the governing body of the city or town prior to formation or expansion of the District; and


**WHEREAS**, the City of Maricopa does not oppose the expansion of the District within Pinal County (see Exhibit "A", the attached map of expansion area and legal description).

Parcel 1

All that real property situate in Section 25, Township 4 South, Range 3 East, Gila and Salt River Base and Meridian, Pinal County, Arizona, more particularly described as follows;

BEGINNING at the Southwest corner of the Southeast quarter of the Southwest quarter of Section 25, a point on the South boundary line of Section 25 and the North boundary line of Section 36, Township 4 South, Range 3 East, Gila and Salt River Base and Meridian, Pinal County, Arizona;

thence North 00 degrees 05 minutes 29 seconds East (North 00 degrees 16 minutes 36 seconds East, record) along the West line of the Southeast quarter of the Southwest quarter of Section 25, a distance of 1340.76 feet (1340.55 feet record) to the Northwest corner of said Southeast quarter, Southwest quarter;

thence South 89 degrees 54 minutes 40 seconds East (South 89 degrees 31 minutes 27 seconds East, record) along the North line of said Southeast quarter, Southwest quarter, a distance of 1311.33 feet (1311.00 feet record) to the Northeast corner of said Southeast quarter Southwest quarter;

thence North 00 degrees 08 minutes 56 seconds East (North 00 degrees 19 minutes 49 seconds East, record) along the West line of the Southeast quarter of Section 25, a distance of 1340.46 feet (1340.20 feet record) to the Northwest corner of the Southeast quarter of said Section 25;

thence North 89 degrees 55 minutes 29 seconds East (South 89 degrees 30 minutes 32 seconds East, record) along the North line of said Southeast quarter, a distance of 2625.36 feet (2625.00 feet record) to the Northeast corner of said Southeast quarter of Section 25;

thence South 00 degrees 15 minutes 51 seconds West (South 00 degrees 26 minutes 18 seconds West, record) along the East line of said Southeast quarter, a distance of 2679.70 feet (2678.99 feet, record) to the Southeast corner of said Section 25, said point also being the Northeast corner of Section 36;

thence West along the South line of Section 25, also the North line of Section 36, an approximate bearing of South 89 degrees 53 minutes 51 seconds West (North 89 degrees 32 minutes 22 seconds West, record) for a distance of approximately 3929.97 feet (3929.68 feet, record) to the POINT OF BEGINNING.

Parcel 2

That portion of Section 36, Township 4 South, Range 3 East, Gila and Salt River Base and Meridian, Pinal County, Arizona, more particularly described as follows:

BEGINNING at the Southeast corner of said Section 36;

thence North 89 degrees 56 minutes 51 seconds West ( North 89 degrees 23 minutes 12 seconds West recorded) along the South line of said Section 36, a distance of 1906.97 feet (1907.41 feet recorded) to a point of intersection with the Northeasterly right of way line of the Maricopa Highway;

thence North 53 degrees 52 minutes 10 seconds West (North 53 degrees 17 minutes 57 seconds West recorded) along said right of way line, a distance of 900.92 feet (900.44 feet recorded) to a point in the East line of the Southwest quarter of said Section 36;

thence North 00 degrees 26 minutes 58 seconds East (North 01 degrees 00 minutes 54 seconds East recorded) along said East line of Southwest quarter, a distance of 2150.13 feet (2150.26 feet recorded) to the Northeast corner of said Southwest quarter;

thence North 89 degrees 58 minutes 56 seconds West (North 89 degrees 25 minutes 13 seconds West recorded) along the North line of said Southwest quarter, a distance of 1315.04 feet (1314.90 feet recorded) to the Southwest corner of the East half of the Northwest quarter of Section 36;

thence North 00 degrees 33 minutes 29 seconds East (North 01 degrees 07 minutes 42 seconds East recorded) along the West line of said East half Northwest quarter, a distance of 2674.07 feet (2674.10 feet recorded) to the Northwest corner of said East half of Northwest quarter;

thence North 00 degrees 05 minutes 29 seconds East (North 00 degrees 16 minutes 36 seconds East recorded) along the West line of the Southeast quarter of the Southwest quarter of Section 25, a distance of 1340.76 feet (1340.56 feet recorded) to the Northwest corner of said Southeast quarter, Southwest quarter;

thence North 89 degrees 54 minutes 40 seconds East (South 89 degrees 31 minutes 27 seconds East recorded) along the North line of said Southeast quarter, Southwest quarter, a distance of 1311.33 feet (1311.00 feet recorded) to the Northeast corner of said Southeast quarter, Southwest quarter;

thence North 00 degrees 19 minutes 49 seconds East (North 00 degrees 19 minutes 49 seconds East recorded) along the West line of the Southeast quarter of Section 25, a

distance of 1340.46 feet (1340.20 feet recorded) to the Northwest corner of the Southeast quarter of said Section 25;

thence South 89 degrees 55 minutes 29 seconds East (South 89 degrees 30 minutes 32 seconds East recorded) along the North line of said Southeast quarter, a distance of 2625.36 feet (2625.00 feet recorded) to the Northeast corner of said Southeast quarter Section 25;

thence South 00 degrees 15 minutes 51 Seconds West (South 00 degrees 26 minutes 18 seconds West recorded) along the East line of said Southeast quarter, a distance of 2679.70 feet (2678.99 feet recorded) to the Southeast corner of said Section 25 said point also being the Northeast corner of Section 36;

thence South 00 degrees 14 minutes 52 seconds West (South 00 degrees 49 minutes 01 seconds West recorded) along the East line of said Section 36, a distance of 1325.65 feet to a point;

thence North 89 degrees 06 minutes 08 seconds West (North 88 degrees 31 minutes 59 seconds West recorded), a distance of 2196.69 feet to a point;

thence South 00 degrees 52 minutes 00 seconds West (South 01 degrees 26 minutes 09 seconds West recorded), a distance of 1288.39 feet (1263.39 feet recorded) to a point;

thence South 89 degrees 40 minutes 40 seconds East (South 89 degrees 06 minutes 31 seconds East recorded); a distance of 1377.63 feet to a point;

thence North 01 degrees 06 minutes 12 seconds West (North 00 degrees 32 minutes 03 seconds West recorded), a distance of 100.00 feet to a point;

thence South 89 degrees 40 minutes 40 seconds East (South 89 degrees 06 minutes 31 seconds East recorded), a distance of 50.00 feet to a point;

thence North 01 degrees 06 minutes 12 seconds West (North 00 degrees 32 minutes 03 seconds West recorded), a distance of 1149.81 feet to a point;

thence South 89 degrees 06 minutes 08 seconds East (South 88 degrees 31 minutes 59 seconds East recorded), a distance of 812.36 feet (811.50 feet recorded) to a point on the East line of said Section 36, said point being South 00 degrees 15 minutes 52 seconds West (South 00 degrees 49 minutes 01 seconds West recorded), a distance of 1350.65 feet from the Northeast corner of said Section 36;

thence South 00 degrees 14 minutes 52 seconds West (South 00 degrees 49 minutes 01 seconds West recorded) along said East line, a distance of 4013.81 feet (4,013.63 feet recorded) to the POINT OF BEGINNING;

EXCEPTING therefrom any portion thereof lying within Section 25, Township 4 South,  
Range 3 East of the Gila and Salt River Base and Meridian, Pinal County, Arizona.
