## **RESOLUTION NO. 07-11**

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING THE MARICOPA POLICE DEPARTMENT TO ENTER INTO A JOINDER AGREEMENT WITH THE ARIZONA PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM ON BEHALF OF THE FULL-TIME PAID POLICE OFFICERS WHO ARE CERTIFIED PEACE OFFICERS AND WHO ARE OR WERE REGULARLY ASSIGNED TO HAZARDOUS DUTY IN THE SATE OF ARIZONA OF THE CITY OF MARICOPA.

WHEREAS, the City of Maricopa did on February 20, 2007, pass Resolution 07-10 authorizing an actuarial survey to be made to determine the estimated cost of participation in the Public Safety Personnel Retirement System; and

WHEREAS, the preliminary actuarial survey will be made and it has been deemed in the best interest of the City of Maricopa to include all full-time (normally works 40 or more hours per week) paid police officers who are certified police officers and who are or were regularly assigned hazardous duty in the State of Arizona under the Public Safety Personnel Retirement System as set forth in Title 38, Chapter 5, Article 4, Arizona Revised Statutes.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Maricopa, Arizona as follows:

The Maricopa Police Department is hereby authorized to sign the Joinder Agreement, attached hereto as Exhibit "A", with the Arizona Public Safety Personnel Retirement System Fund Manager.
