

## **RESOLUTION NO. 07-20**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING AN AMENDMENT TO THE SUBMISSION OF AN APPLICATION FOR FISCAL YEAR 2007 STATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND STATE SPECIAL PROJECT FUNDS, CERTIFYING THAT SAID AMENDED APPLICATION MEETS THE CITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENT OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN THE AMENDED APPLICATION.**

**WHEREAS**, on March 6, 2007, the City of Maricopa approved Resolution No. 07-12 regarding the submission of an application for the CDBG and State Special Project Funds for receipt and use of funds for Street Improvements and a Mobile Command Vehicle;

**WHEREAS**, the City of Maricopa would like to amend the application to use the funds for Street Improvements and Park Improvements rather than for Street Improvements and a Mobile Command Vehicle;

**WHEREAS**, the State CDBG Program requires that CDBG funds requested address one of the three Congressional mandated National Objectives; and

**WHEREAS**, the activities within this amended application will address the City's identified housing and community development needs, including the needs of low and moderate income persons; and

**WHEREAS**, an Applicant of State CDBG funds is required to comply with the program guidelines and Federal Statutes and regulations.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Maricopa, Arizona that the City of Maricopa is hereby authorized to submit an amendment to the application to the State of Arizona, Department of Housing for Fiscal Year 2007 CDBG funds and that the Mayor is authorized to sign the amended application and contract or grant documents for receipt and use of these funds for Street Improvements and Park Improvements, and to take all actions necessary to implement and complete the activities submitted in said amended application.

**BE IT FURTHER RESOLVED** by the Mayor and City Council of the City of Maricopa, Arizona that this amended application for State CDBG funds meets the requirements of low and moderate income benefit for activities justified as benefitting low and moderate income persons, aids in the prevention or elimination of slum and blight or addresses an urgent need which poses a threat to health.


**BE IT FURTHER RESOLVED** by the Mayor and City Council of the City of Maricopa, Arizona that the City of Maricopa will comply with all State CDBG Program guidelines, Federal Statutes and regulations applicable to the State CDBG Program and the certifications contained in the amended application.
